REGULAR COUNCIL MEETING FEBRUARY 7, 2022

The regular meeting of the Spring Valley City Council was held in the City Hall Council Chambers, 215 N. Greenwood Street, Spring Valley, Il. 61362 and called to order by Mayor Malooley Thompson at 7:00 p.m. with the following Aldermen answering present to the roll call: Mike Herrmann, Ed Jauch, Chris Affelt, Jen Diaz, Greg Campbell, Deb Baltikauski, Ken Bogacz and Dave Pellegrini. 8 present.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

#14326 Moved by Alderman Baltikauski and seconded by Jauch that we dispense with the reading of the minutes of the last regular meeting and approve them as presented. Aye votes: Herrmann, Jauch, Affelt, Diaz, Campbell, Baltikauski, Bogacz and Pellegrini. 8 ayes. Motion carried.

The list of bills was presented, a copy of which was given to each Alderman 48 hours prior to the meeting.

Chief Curran reported the fire alarm panel has been fixed noting a bad part was draining the battery. The system we have now is obsolete and will be very costly to replace when the time comes. Chief Curran also noted testing for Police Officers is scheduled for Saturday and interviews will be held 10 days later.

Superintendent Norton reported Maguire Iron would like to meet with the council to discuss our water tower maintenance. Norton also noted he has received very few applications for a laborer and would like to know what we should do next. Alderman Pellegrini noted the Park Board will also be needing to hire a park supervisor. Mayor Malooley Thompson will post the positions on Indeed.

Alderman Affelt scheduled a Public Utilities Committee meeting for Tuesday February 22, 2022 at 6:30 p.m. to hear a presentation from Maguire Iron for water tower maintenance. Alderman Pellegrini scheduled a Finance Committee meeting as well noting Fire Chief Bogatitus will be present to review his annual report and issues with his part-time staffing.

Mike Richetta from Chamlin and Associates started topographic work for the 4th Street project and he needs to locate the water and sewer and will then move forward, he has no update for the Oak Street project but will be working on it next week and noted the temporary AT&T cell towers have been removed from the St. Bede water tower and the new cell towers are in place.

Mike Richetta from Chamlin and Associates reported he looked at the Buckman property and found no obvious dumping on the site. He has also spoke with Aperion Care regarding the grease trap and grinder noting the proposed grinder was already approved by the city and they can begin working on that. Aperion is to get back to him within a week.

He suggested we use the Bureau County States Attorney as the audit official. There was discussion on whether that is the right person to put in that role as they could possibly be involved in one way or another. The auditing official on the policy shall be the State's Attorney of Bureau County.
