REGULAR COUNCIL MEETING JULY 1, 2024

The regular meeting of the Spring Valley City Council was held in the City Hall Council Chambers, 215 N. Greenwood Street, Spring Valley, II. 61362 and called to order at 7:00 p.m. with the following Aldermen answering present to the roll call: Mike Herrmann, C.J. VanSchaick, Jeff Chiaventone, Deb Baltikauski, Ken Bogacz and Dave Pellegrini. Absent: Chris Affelt and Greg Campbell. 6 present. 2 absent.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

Public comments – Nora Cosgrove spoke on behalf of herself and neighbors regarding parking issues with Mr. John French noting that it is hard to see when his large trucks are parked along Greenwood Street between Dakota and Cleveland Street. Mayor Malooley Thompson told the residents that the city updated our parking ordinance at the last regular meeting and has spoke with Mr. French making him aware that if any vehicle exceeding 8000 pounds is parked there he will be ticketed. She asked residents to contact the police department if they see any illegal vehicles parked there. There was discussion regarding the parking and Mayor Malooley Thompson noted if it continues to be a problem we will revisit the concern.

Mayor Malooley Thompson noted the formation of a Fire District would be up to the tax payers. Fire Chief Bogatitus explained it is a work in progress including collecting and filing signatures to allow putting the

formation of a Fire District on the November ballot. Bogatitus noted he collected 100 signatures, explained the formation to everyone who signed and they all said we need the fire department and they are willing to pay extra for it. If a Fire Protection District is formed the city would not be financially responsible for the fire department. Bogatitus feels it would be the best way to help the community as it would increase the tax dollars for the fire department and would take effect with next levy following the election if passed. It was noted that the County Board would appoint 3 persons to be in charge of the Fire District. Chief Bogatitus also noted if the district is not passed he would be asking the City for additional funds from the General Fund each year.
