REGULAR COUNCIL MEETING JUNE 3, 2024

The regular meeting of the Spring Valley City Council was held in the City Hall Council Chambers, 215 N. Greenwood Street, Spring Valley, II. 61362 and called to order at 7:00 p.m. with the following Aldermen answering present to the roll call: Mike Herrmann, C.J. VanSchaick, Chris Affelt, Jeff Chiaventone, Greg Campbell, Deb Baltikauski, Ken Bogacz and Dave Pellegrini. 8 present.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

There were no public comments on agenda items.

The following report was received and placed on file:

Mayor Malooley Thompson reported we are re-applying for the OSLAD grant with the same project as last time with revisions and she also attended a preliminary meeting to discuss the Rebuild Downtowns & Main Streets grant and once we receive cost estimates she will share with the council to make a decision on which project to submit.

Alderman Pellegrini reminded the council Summer Fest is this weekend and noted there is good entertainment and is hopeful is a nice day with good attendance. Pellegrini also noted fireworks will be the same night.

Chief Curran introduced the newest full time Police Officer, Ralphie Romo, to the mayor and council, noted the scholarship application date has ended and there are two applicants being considered for the \$500. Scholarship and reported on testing, interviews and promotional exams noting we will be hiring 2 or 3 new officers.

Mike Richetta from Chamlin and Associates reported Caroline Street is near completion, the street program is ready for submittal and he will be reviewing it with Alderman Bogacz.

Superintendent Norton reported that Cruz Concrete was working on an alley approach and found a watermain valve was rotted and leaking. Norton noted if we can't get it shut down we will need to install an EZ valve which will cost about \$15,000. The Street Department is doing what they can to get it shut down.

Chief Curran gave a follow-up on the police officer testing, noted he will be hiring 2 officers, the school resource officer is on schedule and asked the council for authorization to purchase a new squad car to replace the vehicle he currently uses. The council had no issues on purchasing a new police vehicle and it will be on the next agenda.

Mike Richetta from Chamlin and Associates reported the Caroline Street watermain project is ready to go and he will be submitting the permit plans. Richetta also reported the Mayor, Economic Director Andrew Ebener and himself have been working on the Mainstreet grant application and he should have a concept plan by the end of the week.

Superintendent Norton reported the Rt. 89 generator is half complete, they will be testing tomorrow to get ready for the Walmart tower painting noting there may be low pressure in some areas, they have cleaned the bathrooms,

fixed the door and cleaned up the parking area at Barto Landing and he would like to replace the picnic table and the septic will need to be cleaned out as well.
